

Privacy Statement

Beyond Digital Solutions Ltd is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Beyond Digital Solutions Ltd Web site and governs data collection and usage. By using the Beyond Digital Solutions Ltd website, you consent to the data practices described in this statement.

Collection of your Personal Information

Beyond Digital Solutions Ltd collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number.
